Class 1. A window box, 23" long x 6" deep x 7 1/4" wide at top, planted with annuals and/or perennials, to include at least one fragrant genus. To be staged hanging on a railing of a gazebo, about 4' from the ground. A 4" x 6" key card listing plant material and exposure (North, South, East, West) is required.

### **Section B "As Bitter As Aloes" ~ Cacti and Succulents**

*Eligible for Award of Merit*

Class 42. Arboreal Collection of at least 5 cut specimens in separate containers, not to exceed 30" in length, to be staged in a space 36" x 30". A 4" x 6" key card listing specimens is required.

Class 43. Botanical Family Collection of at least 5 or more plants from one botanical family, staged in a space 36" x 30". A 4" x 6" key card identifying plant material is required.

Class 44. Window Sill Display of at least 5 different container-grown plants suitable for a window having a specific directional exposure, staged in a space 36" x 30". A 4" x 6" key card with plant material and exposure is required.

**Section J Rosemary For Remembrance ~ Heritage Plants**

Class 45. Plant must be over 5 years old.

**Section K Sweet Cicely For The Faint-Hearted ~ Judges Challenge**

*Eligible for Award of Merit*

Class 46. *Hippeastrum* 'Exotica' - Exotica Amaryllis

Class 47. *Pelargonium graveolens* var. - Scented Geranium Grey Lady Plymouth

Class 48. *Pelargonium* 'Torento' - Scented Geranium Ginger

**Horticulture Rules ~ Herb Lore**

1. Horticulture classes are open to all amateur gardeners. Advance registration is requested. Please enter everything you think might be ready at show time. There is no penalty for withdrawing material that is not show ready. **Entries may be registered no later than Saturday, February 13, 2010. Send advance entries to Ronnie Schoelzel (address, phone and Email below)**
2. Horticulture entries will be accepted at the CT Convention Center on **Tuesday, February 16, 12 pm -7 pm and Wednesday, February 17, 8 am – 11 am. Late entries will not be accepted.**
3. All entries must be well groomed. Diseased or infected plant material will not be accepted. All entries must be fresh and have been in the possession of the exhibitor for at least ninety (90) days (11/18/09), except for multiple plantings in Class 1 that must have been in the exhibitor's possession for at least six (6) weeks. Water thoroughly before bringing entries to the show. TLC will be given to all specimens. Clean, neutral colored pots, with saucers, are preferred for container-grown plants. Bottles and wedging will be provided for cut specimens. All entries must be botanically named, with variety if possible. Top Awards cannot be given to improperly named entries. Classes 1, 42, 43 and 44 must be accompanied by a typed or printed key card correctly identifying all plant material.
4. More than one entry per class may be made by exhibitors provided each is of a different cultivar, color, or type. Classes will be subdivided by cultivar, color, and type if it aids in judging.
5. Refer to the 2007 edition of the Handbook for Flower Shows pp. 270-271 for the appropriate scale of points when selecting your entries.

**Horticulture Top Awards Offered**

- **The Award of Horticultural Excellence** may be given to the NAMED exhibit judged to be the finest in the entire Horticulture Division. Only one may be awarded.
- **Grower's Choice Award** may be awarded to container-grown plants and/or combination plantings in Sections E and F. Two may be awarded.
- **The Award of Merit** may be given at the discretion of the judges to the NAMED blue-ribbon winner scoring 95 or above in each of Sections B, C, D, G, and K. A total of 5 may be given, only one in each Section.
- **The Collectors Showcase Award** may be given to the NAMED blue-ribbon winner scoring 95 or above in Section I. Only one may be awarded.
- **The Arboreal Award** may be given to the NAMED blue-ribbon winner scoring 95 or above in Section H. Only one may be given.
- **The Connecticut Group Horticultural Award** may be given in Section A for a blue-ribbon winner scoring 95 or above. Only one may be awarded.
- **The Elisabeth Swain Memorial Propagation Award** may be given to an outstanding NAMED blue-ribbon winner scoring 95 or above, propagated by an exhibitor, in the Horticulture Division. Only one may be awarded.

### General Rules

1. This is a Standard Flower Show according to the requirements of National Garden Clubs, Inc. The NGC Standard System of Awarding will be used, see HB pp. 5-7. Decisions of the Judges are final. Judging will begin promptly at **1:30 pm on Wednesday, February 17, 2010.**
2. All Horticulture classes are open to any amateur gardener. All Design classes are open only to NGC members. The Special Exhibits Division is open to garden club members, Youth and Education –oriented groups, in keeping with NGC goals.
3. Plants named on the *CT Preservation List of Wild Plants 2004* ed. may not be used in any division.
4. No artificial flower, foliage, fruits or vegetables are permitted in any division. The emphasis must be on fresh plant material.
5. Only Classification Chairs and other authorized personnel will be allowed in the exhibition room during judging.
6. The Show will open to the public at 10 am to 8 pm on Thursday, Friday and Saturday, February 18<sup>th</sup> through February 20, and Sunday, February 21, the show will be open from 10 am until 6 pm.
7. All entries must be removed between **6 pm and 7 pm on Sunday, February 21, 2010.** There will be no access to the Loading Dock until 6:00. You must park in the CTCC parking garage before 6:00.
8. Although care will be taken, The Federated Garden Clubs of CT, the CT Convention Center and North East Expos, cannot be responsible for loss or damage. All properties should be marked with the name and telephone number of the exhibitor.
9. **NGC Special Award:** One or more may be awarded in recognition of individual effort or contribution to the success of an Advanced-Standard Flower Show.

### Design Division Rules ~ How Sweet It Is

1. Advance registration is required in all classes, made by contacting the Class Consultant. Entries **must be registered by February 1, 2010.** All Design Exhibitors **MUST** find a replacement if unable to exhibit.
2. Entries will be accepted on **Tuesday, February, 16, 3 pm - 7 pm and Wednesday, February 17, 8 am – 11 am.** A printed list of plant material **MUST** accompany the exhibit. Exhibitors **MAY** print a brief comment and/or interpretation on a 3" x 5" card.
3. An exhibitor may enter as many classes as desired, but only one exhibit per class.
4. No fresh CUT fruit or vegetables will be allowed. Whole fruit and vegetables are allowed where permitted.
5. Fresh plant material may not be treated in any manner.
6. Some plant material must be used in every exhibit.
7. Landscapes or scenes are not permitted.
8. Treated or otherwise embellished dried plant material is permitted.
9. Contrived flowers and/or plant forms constructed of recognizable plant material are permitted in all classes, as long as specific plant material requirements are met.
10. No mammals, fish, birds, insects, reptiles, alive or preserved, are permitted.
11. American flags may not be incorporated into any design nor be used as underlays, swags or the like.
12. All pedestals may be incorporated into designs. To incorporate is "to blend, combine or include, to form one harmonious whole". Exhibitors may not cover completely or alter size of pedestal.
13. Consultants will have information on backdrops behind designs.
14. Please refer to the **2007** edition of the NGC Handbook for Flower Shows for specific Design information.

### Design Top Awards Offered

- **Award of Design Excellence:** Awarded to the highest scoring exhibit in the entire Design Division entered by a single exhibitor. Section C, Club Competition Section, is not eligible.
- **Club Competition Award:** One is offered in Section C, class 7.
- **Table Artistry Award:** Designer's choice of fresh and/or dried plant material and other components. Pattern and maker of china, etc. should be listed on entry card. One is offered in Section A.
- **Petite Award:** Designer's Choice of Plant Material in all classes. One is offered in Section F.
- **Designer's Choice Award:** Designer has complete freedom to choose plant material and other components. Do not use anything on Preservation List Categories I and II. Two are offered-one in Section D and one in Section E.
- **CT Judges Design Award:** This award may be given to an outstanding exhibit, scoring 95 or more, in a design class which is ineligible for an NGC Award. One is offered in Section B.
- **The Nell McGuinness Award:** A Certificate may be given to the most outstanding exhibit in the Design Division. A traveling tray is presented at the October Awards Meeting.
- **The Terry Stoleson Award:** Awarded to the design that best represents the creativity, imagination, and originality in Creative Design.
- **Scale of Points for Designs:** See Handbook Page 303, for scale for specific Design Type. Top Awards must score 95 or above.

Class 1. **BRIGHT BLING** ~ A piece of jewelry, staged on a box covered in black by committee.

Class 2. **COLLECTABLE CANDLESTICKS** ~ A candleholder created of recycled materials, minimum size 15" H, staged on a box, covered in black by Committee

Class 3. **PICTURE PERFECT** - A picture frame, minimum size 12"x15", staged on a box covered in black by Committee.

## Section C ~ Educational Exhibits

### Special Exhibits Rules

1. Advance registration with Consultant is required in all Sections of this Division by February 6, 2010.
2. Artistic Crafts must be the work of one exhibitor. Educational Exhibits may be the work of a group.
3. All exhibits must contain some plant material. Only dried material may be treated to alter its external appearance.
4. Artificial plant material is not permitted.
5. Educational Exhibits must occupy a minimum of 18 square feet of surface area.
6. Special Exhibits Scales of Points see HB p.304. Exhibits will be judged by NGC Standard System of Awards.

### Special Exhibits Top Awards Offered

- **Educational Award:** One is offered and may be awarded to the highest scoring exhibit in the Educational Section which scores 95 or above. Must meet space requirements.
- **Youth Educational Exhibits Award:** One may be given to the exhibit scoring 90 or above. Section A is eligible.
- **Artistic Craft Award:** One may be given to the highest scoring craft with 95 or above in Section B.
- **Award of Appreciation:** One or more may be given to Invitational and Commercial Exhibits.
- **CT Judges Special Award:** One may be given to an Educational or Special Exhibit scoring 94 or more which awakens interest in a subject and stimulates the viewer to learn more.
- **CT Silver & Blue Award:** One or more may be given to Educational Exhibits scoring 90 or more but not receiving an NGC Educational Award or the CT Judges Special Award. Section C is Eligible.
